More adventures in car shopping

As many of you might recall I sold my Model S in the fall as it was just collecting dust. We were doing fine with the i-Miev and the Bolt, but this summer revealed a few gaps in our car capability matrix. Our LT trim Bolt doesn't have a good way to mount a roof rack on it, and we have a 2 person Kayak hanging in the garage that doesn't have a ride without a roof rack on either car. The second gap is the wife wants to go visit her family in Fort Wayne IN, and there isn't any fast charging in that area except Tesla. Lastly my son has taken up fencing, with an instructor in Kenosha WI. We are starting to see situations where Scott needs to be in Kenosha on the same day the wife or I need to be somewhere else in the opposite direction beyond the reach of the imiev. It hasn't happened yet, but it will before the summer is out.

As you might have heard, Rental Cars are unusually expensive, so it isn't as practical as normal to just rent a car for a weekend. Most used and new cars are more expensive than average. The one area of the market that hasn't gone up considerably is used Teslas. They are up, but only by a few percent compared to other cars that have gone up ten percent or much more. This may change as new Tesla lead times have recently gone from a few weeks to a few months. That isn't to say buying a used Tesla was easy, but I have managed to get a private seller in California to sell me a 2018 Model 3 Long Range with 52k for \$35k. Should this car be \$35k, no, probably not, but it was \$35k all winter long and it's still \$35k, if you can find one. Model 3's have held their value extremely well, and maybe that will continue, but I expect to have this one for a while (yeah yeah). Tesla sells a roof rack for this vehicle, which should hold the Kayak without issue, and the Fort Wayne issue is solved by the excellent Tesla Supercharger network.

Keeping with the usual Jeff theme though, the Bolt might be finding a new home in the club as one of the Volt's has recently been in an accident. As I am writing this it is being evaluated, but the body shop expects it to be retired. I like the Bolt, and if the Volt is repaired I will probably keep it as it is a nice car and I would just end up buying a used one, or possibly the EUV version once prices return from space. If used Bolts get really cheap this winter I can see me possibly selling the imiev and buying another Bolt for my son, because he would like to attend Fencing more than once per week. This isn't something I anticipated when I bought the imiev, interested parties might contact me. I only paid \$2900 for it, so it would stand to reason that I would sell it for that or less. So it's possible by the end of the year I will own a Model 3, and two Bolts, or a Model 3 and an imiev, or???

But wait there's more! I have also put in a Ford F150 Lightning reservation for my wife. Does that factor in there somewhere, probably, but not for another 18 months, and we all know I might sell all my cars again by then.

Buying or selling cars and why I avoid dealers now more than ever

If you live in Illinois you might be aware that the state reduced the sales tax exemption on trade-in to

\$10,000. Has this affected my behavior, you BET. Before I could trade a car into the dealer and only pay sales tax on the difference in value, but now if you trade in a \$25K car, you pay sales tax on \$15K more than you would have previously. Add in that dealer doc fees are now allowed to be \$300 and the penalty for going to the dealer begins to really add up, and the benefit is limited to only the sales tax avoidance on \$10K. On top of that private party purchases are taxed differently than dealer purchases.

Here is the form, in the bottom right corner is the table of interest. In general the tax is around half as much compared to paying the actual sales tax rate. For those of you that live in higher tax locations like the City of Chicago, this will be even more advantageous.

So avoiding the doc fee, the higher sales tax, and the reduced tax avoidance on trade in has put me farther down the path of selling private party as often as possible, and strongly preferring buying private party when shopping used. The Model 3 is being purchased from a private party.

A note on private party, ask if the owner has a loan on the car very early in the process. I won't say don't buy the car if it has a loan / lien on the title, but you will need to work with the buyer to sort it out. If it comes up my first suggestion is if the person doesn't have the cash to pay it off directly, that they contact their bank and see if they will send the title to a local branch so we can do the deal there and get the title immediately upon payment. (I choose lenders that offer this) If that isn't an option, then find out what expedite services they offer. At that point I suggest they explore taking a loan from their employer's 401k plan and then paying that off once the transaction completes. If none of those options are available, then it could easily be a two week wait between when you pay for the car, and when you get the title. You can't register the car, or even get temp plates until you have the title, so you own a paperweight for that period. A paperweight you have to insure, and possibly pay interest on (if you have a loan). This isn't good, and bad things can happen because the bank will send the seller the title when the loan is paid off, and you are relying on the buyer to do the right thing. You should have a bill of sale covering this, but still, it can get ugly, and getting a title, and a car immediately upon payment is by far the best case. Just make sure that any liens have been released by the bank.

As always feel free to reach out to the group if you find yourself wanting to explore a private party transaction, preferably before you start the search. Besides, there might be the car you want sitting in my garage waiting for you to buy it.



EVC will become a Franchisor (when the US government approves the conversion rebate) to appoint Franchisees (eg, service stations, oil change shops, transmission shops, independent mechanics, etc.) to convert Internal Combustion Engine (ICE) vehicles to electric vehicles (EV).
