### **EVSE** updates

Everyday I learn about yet another EVSE charging station company. (I am exaggerating) I recently learned about Cyber Switching EVSE.

Considering it has a 4G modem in it, this isn't a terrible price. It also supports load sharing and other smart charger features. I have never seen one of these in the wild myself, however four of them are going to be installed at McHenry County College and will be free to the public. This caused me to look around to see what else was out there now for affordable charging. After browsing the usual suspects I stumbled on the latest offering from Tesla, the Universal Wall Connector.

This is a very positive review. For the reasonable sum of \$595 for the unit, and \$425 for the pedestal, it is an affordable solution for a 48 amp, J1772 and NACS connector station. It doesn't have a 4G modem, so you are limited to wifi. If that isn't an issue though, it's quite reasonable. Also mentioned in that review is that the Hilton hotel chain is buying 20,000 of them. I am excited to see where they turn up!

### Update on my very small electrical and mechanical company

I have filed the LLC and am working through all of the paperwork for my new mechanical and electrical company. Everything should be done for the December newsletter, so I will give more updates there. I am taking the Master Electrician exam the morning of the next meeting, so hopefully that goes smoothly.

### **Illinois State Agencies to Purchase EV's**

A recent bill just passed in the Illinois Legislature that requires all state agencies to purchase electric vehicles when they purchase new vehicles. It is headed to the governor's desk for his signature. We can help ensure this bill becomes law.

I ask that each one of us pickup our phone and dial 217-782-6830(or 6831) and say **"Please tell Governor Pritzker to support SB1769 which requires state agencies to purchase EV's when they purchase new vehicles"**. The people you talk to are very polite and do listen. It's quick, easy, and please know **your call does make a difference.** 

### **Networked Geothermal Systems**

We all are familiar with geothermal heat pumps. Now networked geothermal is here.

It's called Thermal Energy Networks (TEN's). It is a proven technology having been used on several college campuses already. Projects using this concept are moving forward in 12 states.

Instead of natural gas, networked geothermal uses interconnected ground source heat pumps. That means pipes running from under the street to buildings and homes are filled only with water, no gas. The system connects buildings with different heating needs. Energy is exchanged or stored in the ground until it is needed.

As a result of the passing of SB1699, the Illinois Commerce Commission is holding a series of workshops on the potential of TEN's and then will prepare a report which includes recommendations for deploying TENs in the state of Illinois. # <u>The Good</u>

*\$27M now available for DC Fast Charging in IL as part of the Rebuild Illinois capital program.* Illinois EPA will fund a portion of the eligible costs associated with new commercial grade Direct Current Fast Charging (DCFC) stations for light-duty electric vehicles to be located at publicly accessible charging station locations in Illinois. # <u>The Bad</u>

**The Illinois EV rebate program is shut down.** The \$4,000 Illinois EV rebate program which runs from November 1, 2023 to Jan 31, 2024 has been shut down. The applications that have been received by the IL EPA has surpassed the amount of available funding. This was anticipated as the amount allocated this round was only \$12.5 million vs. last year in which \$25 million dollars was allocated. To put this in perspective, last year about 7,600 EV's received the rebate but with the lower budgeted amount only 3000 cars can get a rebate this year.


# The Ugly

**UN Study concludes global fossil fuel production plans far exceed climate targets**-Reuters Nov & Global fossil fuel production in 2030 is set to be more than double the level deemed consistent with meeting climate goals set under the 2015 Paris climate agreement, the United Nations and researchers said on Wednesday Nov 7<sup>th</sup>. The U.N. Environment Program's (UNEP) report, assessing the gap in fossil fuel production cuts and what's needed to meet climate goals, comes ahead of the global COP 28 climate meeting which starts on Nov. 30<sup>th</sup> in the United Arab Emirates. ### Fires in Parking Garages

Just recently, October 10th, a fire started in a large multi story car park at Luton Airport in the UK. It is not surprising that the anti EV community immediately latched on to this event that destroyed about 1500 vehicles. However it was soon determined from video footage of the vehicle that initially caught fire, by running its license plate (Registration number), against the vehicle registration agency and it was determined that it was a diesel fueled Range Rover.

So, in my fire alarm thinking mode I started contemplating vehicles in garages, especially the attached garages that many have at home. Some people may have a fire alarm system that monitors areas such as the garage with heat sensors. But not smoke detectors for obvious reasons. However, fire usually starts with smoke and that would be the preferred method of detection. Sprinkler systems are not necessarily a good idea in the case of a fuel situation since water can actually spread the fuel around or even vaporize the diesel fuel and oils if there's already significant heat.

The other thought is that since most newer vehicles 'call home' it would not be unreasonable to expect the vehicle to call for help... Any thoughts? Anything that makes our environment safer can't be a bad thing!


### Encouraging Our Membership To Grow and Some History
